



# Dan Vickers: Advancing Podiatric Medicine and Surgery Through Education

The Podiatry Institute's executive director is elected to the *PM* Hall of Fame.

As Director of Medical Education for the Podiatry Institute and previous inductee into the *PM* Podiatry Hall of Fame Award, I am honored to acknowledge Daniel F. Vickers, CAE, as *Podiatry Management's* 2018 Inductee into the *Podiatry Hall of Fame*, and chronicle the many contributions Mr. Vickers has given to the profession of podiatry.

Dan received his bachelor's degree from the University of Georgia in 1980 and served as Operations Manager for the Ben Meadows Company through 1986. Mr. Vickers joined the Podiatry Institute as Executive Director on January 12, 1987. He is currently in his 31st year as the Executive Director. During that tenure, he completed requirements for his Master in Business Administration (MBA) in 1993 at Mercer University in Atlanta and became certified with the American Society of Associations Executives in 1999. Mr. Vickers has also served as the president of the Georgia Society of Associations Executives during 2003–2004.

Dan has fulfilled a critical leadership role in podiatric continuing medical education (CME). One of the very first challenges Dan was charged with when he was hired to

lead the Podiatry Institute was the receipt and distribution of over 15,000 copies of the first edition of *McGlamry's Textbook of Foot and Ankle Surgery* from the operations center based in E. Dalton's basement! Since that event, he has guided the Podiatry Institute in the publication of the 2nd, 3rd and 4th editions of the textbook, even serving as "author's editor" for

the 4th edition. Mr. Vickers has been responsible for many other publications from the Institute over the last 30 years, including the 31 annual publications of the *Podiatry Institute Update*, 3 editions of the *PI Manual* edited by D. Scot Malay, the *Textbook for Podiatric Medical Assistants*, multiple slide series, educational films, and workbooks.

Dan has guided the Podiatry Institute in one of its primary missions of disseminating post-graduate medical education throughout the profession. He has directed hundreds of post-graduate medical education courses which have included over 300 CME seminar courses held throughout the United States with over 57,000 attendees in the last 30 years. He has guided over 300 in-house Cadaver Surgical Skills courses, literally held every month over the last 30 years; these courses have provided hands-on training in foot and ankle surgery to more than 3,000 podiatric and orthopedic surgeons from the United States, Canada, Australia, Spain, Great Britain, South America, Germany and China. His efforts have also included eight international courses in Germany, Italy, and Canada.

Dan has also been instrumental in the evolution of one of the funda-

mental training courses in podiatric education in the skills and techniques of skeletal fixation. In cooperation with AONA, training courses were held for 20 years from 1993 through 2013. At the end of 2013, the independent organization American Association of Foot and Ankle Osteosynthesis (AAFAO) was created. Dan has served as the Executive Director of this organization under the guidance of its Board of Directors, including Jack Schubert, Brian Carpenter, Mary Crawford, Chuck Gudas, Jim Thomas, and Gage Caudell. During 2013–2017, AAFAO in conjunction with Smith & Nephew provided intense basic and advanced courses on internal and external fixation skills to over 1500 podiatric residents. Beginning in 2018, the AAFAO will expand, having six courses capable of providing advanced skills training to over 700 residents each year.

Mr. Vickers has also worked closely with Dr. Michael McGlamry, the Corporate Liaison for the Podiatry Institute, in fostering a cooperative effort with corporate partners to support the continuing production of podiatric education seminars.

were at a point where our growth had plateaued, the mission was unclear, and we recognized that something was missing in order to allow us to reach our potential. We agreed that a staff executive director was needed. A few months later, Dan

and a continuing education program that changed the type of education podiatric physicians could experience, often by bringing the meetings to regions all over the country.

Dan's calm demeanor combined with a firmness of purpose has been

Vickers came on board as our first full-time Executive Director. There were about 25 faculty members doing three to four meetings per year with an annual budget of \$250,000. Fast forward to today and we have been through four editions of *McGlamry’s Comprehensive Textbook of Foot and Ankle Surgery*, with a faculty of over 120 doing 15-16 meetings per year with about 3,000 attendees annually on a budget of \$2.3 million. Dan has been the glue that has helped a faculty spread across the country function
